- Official action requires approval of a majority of the voting members
- Legislator members are nonvoting members and act in an advisory capacity only
- The task force has 13 voting members, so at least 7 are required for a quorum or vote
- Task force must elect a chair
- If there is a vacancy for any cause, the appointing authority (Senate President and House Speaker for legislators; Governor for everyone else) will appoint new members
- The task force may adopt "rules necessary for the operation of the task force"
