



## Quick Start Guide for New Workday Learning Users

---

This document will guide you through setting up an account so you can complete online training offered by the Oregon Department of Justice Crime Victim and Survivor Services Division (CVSSD).

If you do not work for a CVSSD grantee program, please contact [cvssd@doj.oregon.gov](mailto:cvssd@doj.oregon.gov) to request access before setting up your account.

If you already have a State of Oregon Workday Learning account but are unable to access it, please contact [DOJWorkdayLearningPartner@doj.state.gov](mailto:DOJWorkdayLearningPartner@doj.state.gov).

Please do not create a duplicate account.

### Create a New Workday Learning Account

1. Visit:

2. For step 1 of 2, select **United States of America**.
3. Click **Register**.
4. For step 2 of 2, enter your **first name**, **last name**, and **email address**.
5. You will receive two additional emails: one containing your username and the other with a temporary password. Use this information to log in to your account and change your password.
6. Choose and answer challenge questions.
  1. From the Password Challenge Questions screen, select four challenge questions.
  2. Supply an answer for each challenge question.
  3. Select **OK**.
  4. Continue navigating to your account.

### Find Online Courses in Workday Learning

1. Log in to Workday Learning.
2. Select the **Learning** icon.
3. From the Learning page, select **Browse Learning Content** from the menu on the right.
4. In the search bar, type **CVSSD**.
5. Find your desired course in the list and select the title.
6. Follow the instructions to enroll in and complete the course.

### Information about Required Courses

If your position or grant funding requires you to complete a CVSSD training, be sure to complete the final exam at the end of the course. You must answer at least 8 out of the 10 questions correctly. You may take the exam and review the course as many times as needed to pass.



## Obtain a Learning Certificate

1. Log in to Workday Learning.
2. Select the **Learning** icon.
3. From the Learning bar on the left side of the screen, select **LRN | Learning Certificates for Export**.
4. You should see your name listed in the Extended Enterprise Learner box. Choose **OK**.
5. Select the **Print** button in the lower left corner of the screen.
6. Your certificate of completion will open, and you will have the option to print or save it.

To become an Address Confidentiality Program (ACP) application assistant, you must complete the ACP online course. Once you finish the course and final exam, download the certificate and include it with your completed [ACP Application Assistant Agreement](#).
