# Consumer Protection Initiatives

- ✓ Secured 9.25-million-dollar settlement with two pharmaceutical giants for inflating prices.
- ✓ Submitted plan to end Google's illegal monopoly over internet search engines.

- ✓ Released 6-month report showing big results for Oregon Consumer Privacy Act (OCPA) in protecting consumer information online.
- ✓ Secured victory in battle against Ticketmaster/Live Nation over inflated ticket prices.

## Consumer Complaints:



- 1,956 complaints closed (removing CAFAs, UTPA, APS, Elder Abuse, and any duplicated complaints)
- Total savings to consumers \$311,245
- 307 complaints have reached a full or partial resolution

## Settlements Secured for Oregon:

1. Antitrust, False Claims, & Privacy Section -State of Oregon, v. Abbvie, Abbott Labs, Unimed Pharma, and Besins Healthcare

State antitrust lawsuit alleging Defendants filed sham patent litigation to delay market entry of generic competitors for its testosterone replacement drug, “AndroGel,” artificially raising prices paid in Oregon. We defeated Defendants’ motions to dismiss, and we reached a settlement for the payment of \$9,250,000 including attorneys’ fee. The Court approved the settlement on March 13, 2025.

2. Civil Recovery Section –In 2025, the Civil Recovery Section has filed two actions seeking injunctive relief, ten actions to recover money owed to state agencies and ten petitions to appoint guardians for vulnerable Oregonians. It has also collected more than \$100,000 in punitive damages that will be used to provide assistance to Oregon crime victims.
